## **RK2 SYSTEMS** LIMITED WARRANTY



RK2 Systems Inc. products are warranted to the initial purchaser to be free of defects in materials and workmanship for a period of 1 year from date of purchase. If such a defect arises during this warranty period, RK2 Systems Incorporated (RK2 Systems Inc.) will, at its option, repair or replace the unit with an equivalent new or factory refurbished unit, subject to the following conditions:

1. The malfunction must be attributable to a defect in materials or workmanship, including repairs performed under this warranty. This limited warranty only applies if the product was not

subject to misuse, negligence, accident, tampering, incorrect wiring, flooded motor or other external causes, improper installation, or any other unintended or unapproved use.

2. RK2 Systems Inc. does not warrant fitness or suitability for use with any particular chemical or fluid compound. Users should undertake sufficient verification and testing of any RK2 Systems Inc. product to determine the suitability (including chemical compatibility) for their own particular purpose. The user must provide to RK2 Systems Inc. certification of the composition of fluids pumped and the actual operating conditions in connection with any warranty request. RK2 Systems Inc. reserves the right to suspend performance of any warranty pending proper certification and evidence of pumped fluids and actual use.

3. All warranty repairs must be performed by RK2 Systems Inc.. Purchaser must retain the purchase receipt and present it with this certificate as proof of ownership and eligibility for warranty repairs. Unauthorized repairs will not be compensated by RK2 Systems Inc.. If unauthorized repairs damage the product, such damages are not eligible for warranty and may void the warranty.

4. Purchaser shall bear all shipping, packing and insurance costs and all other costs associated with the warranty claim, excluding labor and parts necessary to effectuate repairs under this warranty.

5. Periodic check-ups are not covered by this warranty.

6. TO THE EXTENT PERMITTED BY LAW, THE WARRANTY AND REMEDIES SET FORTH HEREIN ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES AND REMEDIES, AND RK2 SYSTEMS INC. SPECIFICALLY DISCLAIMS ALL STATUTORY OR IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND AGAINST HIDDEN OR LATENT DEFECTS. IF RK2 SYSTEMS INC. CANNOT LAWFULLY DISCLAIM STATUTORY OR IMPLIED WARRANTIES, THEN TO THE EXTENT PERMITTED BY LAW, ALL SUCH WARRANTIES SHALL BE LIMITED IN DURATION TO THE DURATION OF THIS

EXPRESS LIMITED WARRANTY AND TO REPAIR OR REPLACEMENT SERVICE AS DETERMINED BY RK2 SYSTEMS INC. IN ITS SOLE DISCRETION. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

9. Rights under this warranty are not assignable without the express prior written consent of RK2 Systems Inc.. Assignee shall have no greater rights than assignor's rights under the limited warranty at the time of transfer.

10. After the warranty period, units requiring maintenance or repair may qualify for the RK2 Systems Inc. exchange program. The exchange program provides an opportunity to repair/replace your pump and/or motor at a nominal charge.
